He has also represented a retailers' association before the Supreme Court in proceedings concerning the ban on sale of liquor near national and state highways.

Aditya has also represented the Stainless Steel Manufacturers and Suppliers Association and other similar associations and certain stainless steel exporters in an anti-subsidy investigation concerning import of certain stainless steel flat products before the Designated Authority and the Delhi High Court.
