Aman Singh Sethi has 10 years of experience working on contentious as well as non-contentious cases.

He has advised clients in high-tech/ disruptive industries, seeds, agrochemicals and agricultural traits, cement, petrochemicals, and telecommunication sectors.

On the enforcement front, Aman has been, and currently is involved in litigious matters before the Competition Commission of India (CCI), the National Company Law Appellate Tribunal as well as the Supreme Court. He has also been involved in a number of challenges against the CCI before various Writ Courts seeking due process and the preservation of natural justice rights.

In the past year, Aman has acted for a number of third parties (as well as a confidential complainant) before the CCI in obtaining favorable decisions against Google for abuse of dominance with Android (subsequently upheld in appeal) and separately, Play Store payments practices (GCR - 'Behavioural Matter of the Year – Asia Pacific, Middle East and Africa' 2023). He has advised and successfully represented clients in opposing (at both first and final appellate stages), Google's pleas to suspend the wide-ranging behavioural remedies imposed by the CCI. He has previously represented *Matrimony.com* in its complaint against Google for alleged abuse of dominance (GCR - 'Behavioural Matter of the Year – Asia Pacific, Middle East and Africa' 2019), and continues to do so in appeal.

Aman has also successfully defended *Uber* against multiple complaints of alleged abuse of dominance and anti-competitive (including hub and spoke) agreements and Indian hospitality disruptor *Oravel Stays Private Limited* for alleged abuse of dominance. In addition, Aman has represented *Monsanto Company* (now *Bayer*), *Ambuja Cements Limited*, *Abbott Healthcare* and the *National Stock Exchange of India Limited* in proceedings pertaining to alleged anti-competitive agreements and abuse of dominance.

Aman has been involved in several major mergers notified to the CCI including advising GSK in obtaining clearance for its exchange of businesses with *Novartis*, *DuPont* in obtaining clearance for the *Dow-DuPont* merger, and *Vodafone* in obtaining a phase I clearance of the *Vodafone-Idea* merger.

Aman has been recognised as a "Rising Star" for Antitrust & Competition, as well as in India as a whole, in Euromoney's 2022 Asia Pacific Awards. Aman routinely writes on issues related to the interplay of competition law and intellectual property, as well as on digital
