- **Tata Group** on the INR 4,000 crore investment in Tata Power Renewables, which is engaged in production of renewable energy in India and overseas, in two equal tranches of INR 2,000 crore each by the Blackrock Real Assets led consortium, including Mubadala Investment Company.
- **Welspun** on sale of its entire renewable energy business (1140 MW) to Tata Power Company Limited, which is operational in various Indian states including Andhra Pradesh, Tamil Nadu, Karnataka, Gujarat, Bihar, Rajasthan and Maharashtra.
